Construction and operations update

Update on modifications to project approval (MOD3)

Late last year, Tomingley Gold Operations (TGO) lodged an application to the NSW Department of Planning and Environment (DPE) to modify the terms of project approval (referred to as MOD3). Following the public exhibition of the MOD3 Environmental Assessment and supporting documentation in November-December 2015. the company responded to information requests from various government agencies, Narromine Shire Council and an adjoining landowner. These responses are currently under consideration by the NSW DPE (http://majorprojects.planning.nsw.gov. au/). The proposed modifications include a change in location of the entrance to future underground mining activities (known as a portal), establishment of the Caloma Two open cut, and a small expansion to the existing Caloma pit.

Continuation of Waste Rock Emplacement rehabilitation

Progressive rehabilitation of the outside faces of TGO's Waste Rock Emplacements (WRE) –

repositories of waste rock extracted from the pits – is continuing as planned. This involves shaping and contouring the outside walls of earth and rock, adding drainage channels, and sowing pasture vegetation consistent with the Tomingley area.

New Independent Chairperson appointed for TGO Community Consultative Committee

Narromine Shire resident and consultant facilitator, James Hamilton, is the new Independent Chairperson of the TGO Community Consultative Committee (CCC). Mr Hamilton, whose appointment has been endorsed by the NSW Department of Planning and Environment, replaces Mark Gardiner, who resigned from the position late in 2015.

Mr Hamilton's combined community involvement and professional experience in community relations, facilitation, mediation and public advocacy make him ideal for the position of Independent Chairperson, which involves balancing resource, environmental and community interests. The purpose of the CCC is to facilitate communication about mine operations and environmental performance, providing a forum for open discussion between mining companies and the community. In addition to the independent chairperson, the CCC comprises representatives of the local community, local council, TGO and other key stakeholders.

The fund contributed \$785 to materials for the construction of a series of raised garden beds located in the quadrangle where some plane trees had to be removed.

The project was carried out by a team of Year 10 boys as part of a multi-phase enhancement program for the school grounds. The beds have been planted out with a Gymea Lily in the centre, surrounded by Dwarf Fountain Grass with 'Little Con' Lomandra as the border plant. The beds are being well utilised as seating by students.
