Update on MOD3 to project approval

Tomingley Gold Operations is continuing to work with the NSW Department of Planning and Environment (DPE) to finalise the modifications to project approval (MOD3), applied for last year. The proposed modifications include a change in location of the entrance to future underground mining activities (known as a portal), establishment of the Caloma Two open cut, and a small expansion to the existing Caloma pit. The Caloma Two deposit and the proposed underground operations below the Wyoming One and Caloma orebodies have now been incorporated into the life-of-mine schedule.

Long-term Tomingley water supply options

The current proposed modifications to project approval (MOD3) also include a number of changes to the original Planning Agreement with Narromine Shire Council. Part of the original Planning Agreement required TGO to provide development contributions for public infrastructure to support construction and operation of the mine. By mutual consent, this agreement has now been amended to explore options for the supply of raw water to the local community.

TGO will take immediate actions to supply raw (untreated) water to the Tomingley village storage dam sufficient to meet current supply needs until the end of the mine's life. In addition, Narromine Shire Council and TGO will jointly work with a consultant to develop a detailed Water Supply Options Report for the Tomingley community beyond the end of mine life.

Other activities around the TGO site

The progressive rehabilitation of the site's waste rock emplacements (WRE) is continuing, with these works being carried out by Revegetation and Erosion Control Services. The next stage of the wall lift on the residue storage facility (RSF) is about to commence. It's anticipated the wall lift around the entire RSF will be completed in September – providing another 12 months' storage capacity. This work will be undertaken by Hardy Brothers Mining and Constructions.
