1 Introduction

Muller Acoustic Consulting Pty Ltd (MAC) has been commissioned by Tomingley Gold Operations Pty Ltd (TGO) to complete a Noise Monitoring Assessment (NMA) for Tomingley Gold Mine ('the mine'), Tomingley, NSW.

The NMA involved quantifying the noise contribution of the mine by direct attended measurements to determine mining noise emissions so that effective management and controls can be implemented where required. The monitoring has been conducted in accordance with the TGO Noise Management Plan and in general accordance with Conditions L4.2 to L4.7 of the EPL at six representative receiver locations. It is noted that this assessment has been completed as part of an internal noise management initiative and does not form part of the annual noise monitoring program to address conditions of the Environmental Protection License (EPL).

The assessment has been conducted in accordance with the following documents:

- NSW Environment Protection Authority (EPA), Noise Policy for Industry (NPI) 2017;
- Environment Protection Licence EPL 20169 (EPL); and
- Australian Standard AS 1055:2018 Acoustics Description and measurement of environmental noise - General Procedures.

A glossary of terms, definitions and abbreviations used in this report is provided in Appendix A.

2 Environmental Protection License Noise Limits

Historic assessments for the mine categorise receivers into Noise Assessment Groups (NAGs). The NAGs were derived based on ambient noise data that controlled receiver RBLs.

Table 1 reproduces the operational and sleep disturbance noise limits for assessed receivers referenced from the EPL that have been adopted for this NMA and are consistent with historic EPL monitoring locations.

3 Methodology

3.1 Locality

TGO is located to the south of the village of Tomingley, NSW. Receivers in the locality surrounding the mine are primarily rural/residential and for consistency the naming conventions for each receiver have been retained from historic noise assessments. The monitoring locations with respect to the mine are presented in the locality plan shown in **Figure 1**.

3.2 Assessment Methodology

The attended noise survey was conducted in general accordance with the procedures described in Australian Standard AS 1055:2018, "Acoustics - Description and Measurement of Environmental Noise" and the EPL. Measurements were carried out using Svantek Type 1, 971 noise analyser between Tuesday 15 September 2020 and Thursday 17 September 2020. The acoustic instrumentation used carries current NATA calibration and complies with AS/NZS IEC 61672.1-2019-Electroacoustics - Sound level meters - Specifications. Calibration of all instrumentation was checked prior to and following measurements. Drift in calibration did not exceed ±0.5dBA.

Both evening and night measurements were of 15 minutes duration. Where possible, throughout each survey the operator quantified the contribution of each significant noise source. Extraneous noise sources were excluded from the analysis to calculate the LAeq(15min) mine noise contribution for comparison against the relevant EPL limit.

Prevailing meteorological conditions for the monitoring period were sourced from TGO's meteorological station and analysed in accordance with Appendix E4 of the NPI to determine the stability category present at the time of each measured sample. This was undertaken to determine applicability of results in accordance with Condition L4.3 of the EPL. Results obtained during non-prevailing meteorological conditions (ie F Class Stability in conjunction with a 2m/s drainage or G Class Stability) are considered not applicable against the EPL criteria.

5 Discussion

5.1 Discussion of Results - Location R2

Monitoring between Tuesday 15 September 2020 and Thursday 17 September 2020 identified that TGO was audible during three measurements at location R2, although the estimated mining contribution remained between <29dBA to 33dBA. Therefore, the relevant noise limit of 35dB LAeq(15min) was satisfied. Extraneous sources such as traffic, insects, dog bark, and wind in trees were audible during the survey periods.

5.2 Discussion of Results - Location R3/R29

Monitoring between Tuesday 15 September 2020 and Thursday 17 September 2020 identified that TGO was audible during three measurements at location R3, although the estimated mining contribution remained between <30dBA to 35dBA. Therefore, the relevant noise limit of 35dB LAeq(15min) was satisfied. Extraneous sources such as traffic, insects and wind in trees were audible during the measurements.

5.3 Discussion of Results - Location R4

Monitoring between Tuesday 15 September 2020 and Thursday 17 September 2020 identified that TGO was audible during two measurements at location R4, although the estimated mining contribution remained between <32dBA to <39dBA. Therefore, the relevant noise limit of 35dB LAeq(15min) was satisfied. Extraneous sources such as birds, insects, traffic, livestock, and wind in trees were audible during the measurements.

5.4 Discussion of Results - Location R5

Monitoring between Tuesday 15 September 2020 and Thursday 17 September 2020 identified that TGO was inaudible during all measurements at location R5. The estimated mining contribution remained below 30dBA, and the relevant noise limit of 35dB LAeq(15min) was satisfied. Extraneous sources such as insects, traffic, offsite drilling, dog bark, and birds were audible during the measurements.



5.5 Discussion of Results - Location R6

Monitoring between Tuesday 15 September 2020 and Thursday 17 September 2020 identified that TGO was audible during five measurements at location R6. Notwithstanding, the estimated mining contribution remained between <30dBA and 34dBA, therefore the relevant noise limit of 35dB LAeq(15min) was satisfied. Extraneous sources such as livestock, traffic, insects, birds, wind in trees, and operator noise were audible during the measurements.

5.6 Discussion of Results - Location R23

Monitoring between Tuesday 15 September 2020 and Thursday 17 September 2020 identified that TGO was audible during three measurements at location R23. Notwithstanding, the estimated mining contribution remained between <30dBA and <36dBA, therefore the relevant noise limits were satisfied. Extraneous sources such as traffic, insects, dog bark, birds, and wind in trees were audible during the survey periods.



6 Comparison of Attended and Unattended Monitoring Results

To address Condition 6 of Schedule 3 of the Project Approval, a program to calibrate and validate the real-time noise monitoring results with the attended monitoring results has been completed.

The validation compares monthly attended monitoring results against the closest assessed unattended monitoring location. Currently, TGO has an unattended real-time monitoring terminal installed at the Brooklands property (nearest to R23). **Figure 1** identifies the location of the monitor with respect to the attended monitoring locations. It is noted that the Brooklands unattended monitor is situated 600m west of the attended noise monitoring location R23, therefore, background (LA90) noise levels are significantly lower due to offset distance to highway traffic.

A comparison of mine noise contributions between attended and unattended noise monitoring demonstrates a general consistency between attended and unattended results. It was noted that dogs barking, insects, birds, and highway traffic noise influenced measured noise levels for this assessment. Furthermore, for September 2020, results remained below the relevant criteria for both attended and unattended locations.

Table 8 provides a summary comparison of results between the attended and unattended noise surveys for R23.

7 Conclusion

Muller Acoustic Consulting Pty Ltd (MAC) has completed a Noise Monitoring Assessment on behalf of Tomingley Gold Operations (TGO). The assessment was completed to provide monthly monitoring data so that TGO can actively quantify and manage site noise emissions.

Attended monitoring conducted from Tuesday 15 September 2020 to Thursday 17 September 2020, identified that TGO mine noise was audible during measurements at five of the monitoring locations R2, R3, R4, R6 and R23, and remained inaudible at R5 during the measurement periods. A review of monitoring data and operator attended observations determined that TGO contributions did not exceed relevant limits during applicable meteorological conditions.

Appendix A - Glossary of Terms



Several technical terms have been used in this report and are explained in **Table A1**.

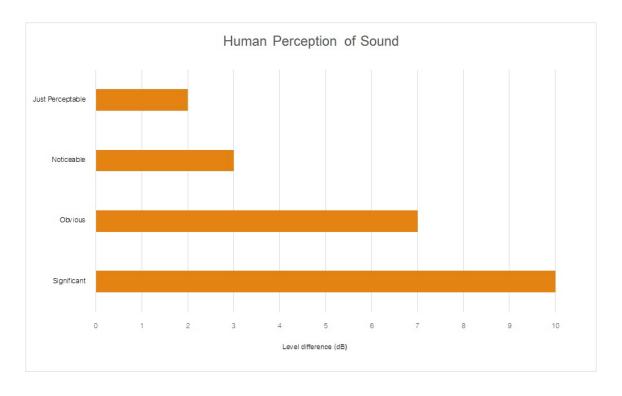

Octave	A division of the frequency range into bands, the upper frequency limit of each band being
	twice the lower frequency limit.
ABL	Assessment Background Level (ABL) is defined in the NPI as a single figure background level
	for each assessment period (day, evening and night). It is the tenth percentile of the measured
	L90 statistical noise levels.
Ambient Noise	The noise associated with a given environment. Typically a composite of sounds from many
	sources located both near and far where no particular sound is dominant.
A Weighting	A standard weighting of the audible frequencies designed to reflect the response of the human
	ear to noise.
dBA	Noise is measured in units called decibels (dB). There are several scales for describing noise,
	the most common being the 'A-weighted' scale. This attempts to closely approximate the
	frequency response of the human ear.
